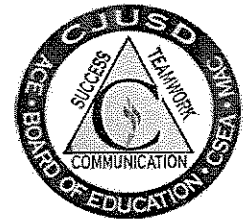




The Board meeting reconvened at 9:14 p.m. Board President Haro reported that no action was taken in closed session.
