**IMPORTANT INFORMATION:**

- ❖ **SAT Fee Waiver:** SAT Fee Waiver maximum value of fees waived per card- SAT: \$52.50, SAT Subject Tests: \$84, QAS/SAS: \$18, Online Course Discount: \$40. Use of a fee waiver also includes coverage of four additional score reports over the user's lifetime. This card does not cover Waitlist Status or change fees. Additional instructions are listed on the fee waiver.
- ❖ **Act Fee Waiver:** covers the basic registration fee covers one report to your high school and up to four college choices (at the time you register). Fee waivers may not be used to pay for: the late registration fee; additional college choices; test date, test center, or test option changes; residual testing; the standby fee; or other services. Fees are listed at [www.actstudent.org](http://www.actstudent.org).
- ❖ I understand that the fee waiver is used once the student registers, even if the student does not test on the requested test date.
- ❖ I understand that if I register online and do not show up to my test I will not only miss a valuable opportunity to test but I also may have prevented other students from testing at that center as well as possibly preventing other students from receiving that fee waiver.
- ❖ I understand that I must present my admission ticket and acceptable photo ID to be admitted to the test center.
