BACKGROUND:	On June 21, 2012, Board President Robert D. Armenta Jr. submitted his resignation, effective June 27, 2012. Mr. Armenta was elected to the Board in 2001 and re-elected in 2005 and 2010. His term in office would have expired in 2014.		
	Board Bylaw 9223, Filling Vacancies, states when a vacancy occurs four or more months before the end of a Board member's term, the Board shall, within 60 days of the date of the vacancy of the filing of the member's deferred resignation, either order an election of make a provisional appointment, unless a special election is mandated according to Education Code 5091.		
	Upon approval of this resolution (order of election), the vacancy will be placed on the November 2012 ballot for voters to elect a new board member. The new board member will serve the remainder of Mr. Armenta's term until November 2014.
